Dear Valued Customers 親愛的客戶,

Shenzhen-Hong Kong Stock Connect (深港通):

The China Securities Regulatory Commission (CSRC) and the Hong Kong Securities and Futures Commission (SFC) have approved the official launch by the Shenzhen Stock Exchange (SZSE), The Stock Exchange of Hong Kong Limited, China Securities Depository and Clearing Corporation Limited and Hong Kong Securities Clearing Company Limited of mutual trading access between the Shenzhen and Hong Kong stock markets (Shenzhen-Hong Kong Stock Connect). Trading will commence on 5 December 2016.

為促進內地與香港資本市場共同發展，中國證券監督管理委員會（以下簡稱中國證監會）、香港證券及期貨事務監察委員會（以下簡稱香港證監會）決定批准深圳證券交易所、香港聯合交易所有限公司、中國證券登記結算有限責任公司、香港中央結算有限公司正式啟動深港股票交易互聯互通機制（以下簡稱深港通）。深港通下的股票交易將於2016年12月5日開始。

There are several issues to note before you can participate in the Shenzhen-Hong Kong Stock Connect, these include but are not limited to:

閣下參與深港通前必須注意以下事項(包括但不限於):

Operation of your TCCS Account 閣下於天宸康合的證券戶口的運作

1. After your Application for Additional Sub-account for Existing Clients to Participate in the Shenzhen-Hong Kong Stock Connect (Annex 1) has been approved, a sub-account will be created (account number starting with "3") under your existing master account at TCCS. For example, if your existing master account number is 17030123, a SZHKSC account with account number 37030123 will be created specifically for you to trade on the SZSE. Alternatively, if your account number starts with an alphabet such as MAM0123, a SZHKSC account with account number 3MAM0123 will be created.

當閣下的現有客戶加開“深港通”子帳戶申請表(附件一)獲批核後，閣下現有的天宸康合證券戶口下將會加開一個“3”字頭的子帳戶作深港通專用戶口(例如: 17030123 (原有主戶口)，會加開一個 37030123 作深港通專用戶口。若戶口號碼由英文字母開始組成，例如 MAM0123，深港通專用戶口號碼將會變成 3MAM0123)。

2. The terms and conditions that apply to the new subaccount (for trading on the SZSE) will be the same as those of the master account.

3. An Authorization for Client Money (see Annex 2) **must** be signed in order for TCCS to transfer any sum of monies interchangeably between any of your segregated accounts at any time for the purpose of SZSE settlement (amount (in any currency) in the master account will be exchanged to Renminbi and transferred to your SZSE account). Please note that this standing authority is valid for a period of 12 months from the date of signing. Please refer to the attached standing authority for further information on its terms and conditions.

Essential Information on Shenzhen-Hong Kong Stock Connect (深港通須知)

4. Trading under Shenzhen-Hong Kong Stock Connect will, initially, be subject to a maximum cross-boundary investment quota (i.e. Aggregate Quota) together with a Daily Quota. Both the Aggregate Quota and the Daily Quota will apply on a “net buy” basis. Under that principle, investors will always be allowed to sell their cross-boundary securities regardless of the quota balance.

通過深港交易通達成的交易初期將受制於一個跨境投資總額度（即總額度）以及一個每日額度。總額度及每日額度按「淨買盤」的基礎計算。根據此原則，不計額度結餘多少，投資者均可隨時出售跨境證券。

The Daily Quota limits the maximum net buy value of cross-boundary trades under each of Shanghai and Shenzhen Connect each day. The Northbound Daily Quota is set at RMB 13 billion for each of Shanghai Connect and Shenzhen Connect, and the Southbound Daily Quota is set at RMB 10.5 billion for each of Shanghai Connect and Shenzhen Connect.

5. Trading Hours 交易時間:

Northbound trading follows SSE's and SZSE's trading hours. However, SEHK will accept Northbound orders from SEHK Participants five minutes before the Mainland market sessions open in the morning and in the afternoon. 北向交易將按照上交所及深交所的交易時間。聯交所將於內地市場早市及午市開市前五分鐘起接納交易所參與者的北向訂單。

6. Trading Currency 交易貨幣:

Hong Kong and overseas investors trade and settle SSE and SZSE Securities in RMB only. Mainland investors trade SEHK Securities in HKD only and settle the trades with ChinaClear or its clearing participants in RMB

香港與海外投資者買賣滬股通及深股通股票將以人民幣進行交易及交收。內地投資者買賣港股通股票將以港幣交易，與中國結算或其參與人則以人民幣交收。

7. Day (Turnaround) Trading 回轉交易:

Day trading is not allowed for both Connect Markets. Therefore, Hong Kong and overseas investors buying SSE and SZSE Securities on T-day can only sell the shares on and after T+1 (see also Pre-trade Checking).

兩個中華通市場均不允許回轉交易。因此，香港與海外投資者於T日買入滬股通及深股通股票後僅可於T+1日或之後賣出（請參考前端監控）。

For Southbound trading, Mainland investors are allowed to conduct day trading for Hong Kong stocks. 至於南向交易，內地投資者買賣港股通股票則可進行回轉交易。

8. Price Limit 價格限制:

For SSE Securities, there is a general price limit of $\pm 10\%$ (and $\pm 5\%$ for stocks under special treatment (i.e. ST and *ST stocks) under risk alert) based on previous closing price. All orders input for SSE Securities must be at or within the price limit. Any order with a price beyond the price limit will be rejected by SSE. The upper and lower price limit will remain the same intra-day.

就滬股通股票而言，上交所目前實行的價格限制一般為不超過前一日收市價的 $\pm 10\%$ （被納入風險警示板的滬股（即ST股票及*ST股票）的價格限制為 $\pm 5\%$ ）。所有滬股通股票訂單的價格必須在價格限制範圍之內，否則訂單會被上交所拒絕。價格限制的上下限在一天之內不會變動。

The same price limit arrangement will apply to SZSE Securities. Stocks traded on SZSE's ChiNext Market are also subject to a $\pm 10\%$ price limit based on the previous closing price. For SEHK Securities, trading follows the existing quotation rules in place on SEHK.

同樣安排也適用於深股通股票。深交所旗下創業板市場買賣的股票亦設前收盤價 $\pm 10\%$ 的價格限制。港股通股票的買賣將按聯交所現時買賣盤報價規則進行。

9. Stock Code, Board Lot/Odd Lot, Order Size and Tick Size

股票代碼、每手單位/碎股、買賣盤規模及最低上落價位:

The stock codes of SSE and SZSE Securities are 6 digits and investors should use SSE and SZSE stock codes when placing orders. All SSE and SZSE Securities are subject to the same trading board lot size, which is 100 shares (buy orders must be in board lots). Odd lot trading is only available for sell orders and all odd lots should be sold in one single order. It is common that a board lot buy order may be matched with different odd lot sell orders, resulting in odd lot trades. It should be noted that unlike Hong Kong, board lot and odd lot orders are both matched on the same platform on SSE and SZSE, and subject to the same share price. The maximum order size is 1 million shares and the tick size is uniformly set at RMB 0.01.

滬股通及深股通股票代碼均為6位數字，因此投資者在輸入滬股通及深股通股票買賣盤時應使用上交所/深交所股票代碼。所有滬股通及深股通股票買賣盤每手均為100股（必須以整手輸入買盤）。僅賣盤可接納碎股，而所有碎股必須以單一賣盤出售。因此，完整買賣單位的買盤訂單與碎股賣盤相撮合形成碎股交易的情況亦屬常見。與香港市場不同，上交所及深交所收到的完整買賣單位的訂單與碎股訂單是在同一交易平台撮合，並在同一價位競價。滬股/深股最大買賣盤為100萬股，最低上落價位劃一為人民幣0.01元。

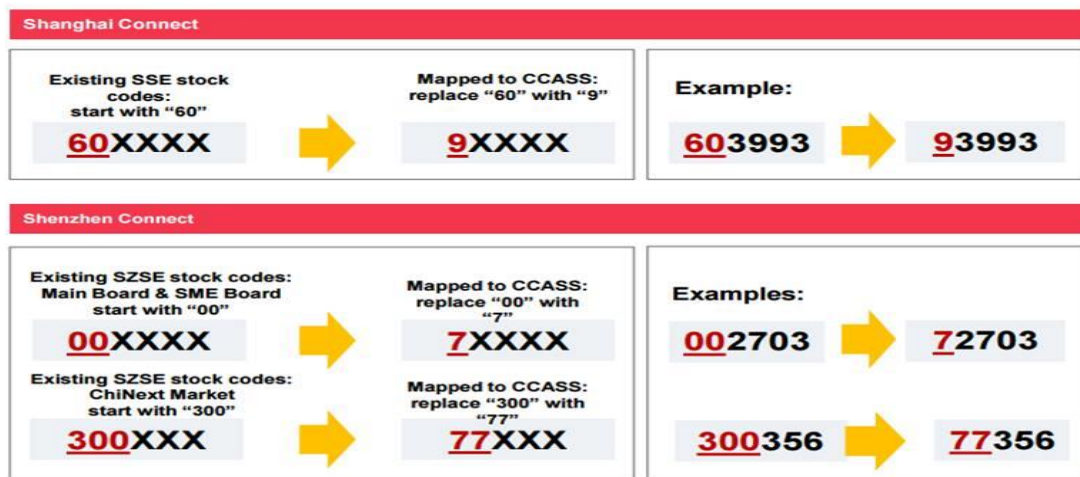

For Southbound trading, all orders are subject to the board lot, order size and tick size requirements of SEHK. Mainland investors are only allowed to input odd lot sell orders. It should be noted that odd lot trading in Hong Kong may likely be executed at a price which is not as favourable as the prevailing market price.

對於南向交易，所有買賣盤均受限於聯交所規則中列明的每手單位、買賣盤規模以及最低上落價位的規定。對於碎股交易，內地投資者只可輸入碎股賣盤。值得注意的是，香港市場的碎股交易可能以較市價為差的價位完成。

10. Short Selling, Margin Financing and Stock Borrowing and Lending

賣空、孖展融資及股票借貸:

Hong Kong and overseas investors cannot participate in the Margin Trading and Securities Lending (融資融券) Programme provided by SSE and SZSE in Mainland China. Naked short selling is prohibited for Northbound trading.

香港及海外投資者不能參與內地上交所及深交所的融資融券計劃，滬股交易通/深股交易通禁止作無擔保賣空。

11. Standard Commission and Fees 標準佣金及收費:

A commission rate of 0.25% of the total transaction amount and a minimum commission charge of RMB 50 for each transaction will be charged (plus any applicable exchange fees).
